1. I/We and our camper will observe and obey all rules and regulations promulgated by the JCA and further agree to follow any oral or written instructions or directions given by camp staff.
2. I/We recognize that there are certain inherent risks associated with camper's participation in camp activities and trips, in transporting camper to and from the camp facility, and in transporting camper on trips, and accordingly, I/We assume full responsibility for personal injuries, property losses, and damages sustained by camper and ourselves, and do further release and discharge the JCA and the Trustee of the JCC Building, as well as their agents, employees, officers, directors, contractors, subcontractors, and volunteers, for all injuries, losses, or damages arising out of camper's use or presence upon the facilities of the day camp, in transporting camper to and from the camp facility, or on any day or overnight trip regardless of fault.
3. I/We agree to indemnify and defend the JCA and the Trustee of the JCC Building, as well as their agents, employees, officers, directors, contractors, subcontractors, and volunteers, against all claims, causes of action, damages, judgments, costs or expenses including attorney's fees and costs, which may in any way arise from camper's use or presence upon the facilities of the JCA day camp in transporting camper to and from the camp facility, or any day or overnight trips.
